- A thank you card was received from 4-H members thanking Leader's Council for their monetary support in attending Montana 4-H Congress this summer.

- Tom Tiarks moved to approve the Treasurer's report and file for audit; Amber Arntzen seconded the motion. Consensus approved Treasurer's Report approved and it will be filed for audit.

- Enrollment Deadline is January 15, 2025
- Project workbooks no longer a requirement for fair/project completion. Look at fair book for how to submit workbooks as a project submission at fair.

- **Food Booth:** A heartfelt thank-you to Yvette for her years of dedication and hard work managing the food booth.
- Ambassadors: The Ambassadors committee reported that they will continue many of the same activities as last year. They are seeking two additional Ambassadors, with the requirement that applicants must be at least 13 years old by October 1. Current Ambassadors include Hailey Gallagher, Davey Storfa, Virgil Tholt, Tristin Gallagher, and Lexi Wichman, under the leadership of Chris England and Nicole Tholt. A media training session is scheduled for November 24 at 2 pm at the Sheriff's Complex, hosted by the Extension Office. The session will focus on dress code, interview skills, and making a strong first impression.

• State 4-H Leaders Council / Montana 4-H Foundation / Extension Office Updates:

- Chris England shared updates from the State 4-H Leaders Council and the Montana 4-H Foundation. The
 council is being reactivated, with Nicole Tholt planning to apply for involvement. Leaders will attend all
 state events, such as Rec Lab and Congress, to educate and support volunteers. A volunteer summit is
 planned for February 2026.
- The 4-H Fundraiser through McDonald's Match raised approximately \$280, the second-highest total in Montana. Chris extended thanks to the three 4-H members who actively promoted the initiative, helping to make it a success.

Special Committees

- Nomination Committee Leaders Council Officer elections and representatives
- Awards/County Awards Program
 - Cassie Yeager gave a short overview of the 2024 county awards ceremony
 - Over 80 kids received county awards; over 200 kids completed 4-H year. Would like to encourage more
 4-Hers to attend the event. The super buckle and small animal best of show buckles were presented.

Old Business

- Independent Member proposal review will be revisited in new business
- Endowment was first discussed during a spring Leader's Council meeting. If there are interested parties or individuals interested in participating on a special committee, please step forward. Is there a deadline? No, but likely need to figure this out in the next 4-H year. We have been accepted with Central Montana Foundation.

New Business

- Officer Elections
 - o Foundation Representative: Yvette moved, seconded by Judy Gregory to nominate Amber Arntzen to represent Fergus/Petroleum 4-H on the Montana 4-H Foundation. Motion was approved unanimously.
 - Leaders Council Secretary: Nicole Tholt moved to nominate Karly DeMars for a second term as secretary.
 Cassie Yaeger seconded. Motion was approved unanimously.
- Budget Report/Approval handout attached to notes
 - o Added line items for coolers
 - Cassie Yaeger moved to approve the proposed budget for the 2024/2025; Davey Storfa seconded. Motion passed unanimously.
- Policy Change
 - o Proposal to change the Roles and Responsibilities of 4-H members (section 7) to update: "7) 4-H members (excluding seniors in high school or a homeschool curriculum last year eligible for 4-H due to age) work a shift in the food booth during fair." This would make the 'senior' member's (described above) requirement to work the 4-H food booth during the fair optional.
 - Hailey Gallagher moved to accept the proposed change as described above. Jordan Grindheim seconded the motion. Motion was approved unanimously.
- Independent Member proposal vote Corry read the summary produced by the appointed anonymous committee. (handout attached to notes)
 - Nicole moved to add the recommended bullet points for Independent members.
 - Under 'Members or Cloverbuds enrolling as "Independent" must meet the following requirements annually', the following bullets would be added:
 - Submit a 4-H New Year Report to the Extension Office no later than January 1st (enrollment deadline). The New Year Report must list the Independent Members' goals for completion of following activities in the 4-H Year:
 - o Community Service Activity how will the member give back to the community?
 - Communication & Public Speaking how will the members use communication skills to engage and/or educate non-family individuals?

- Engage in Learning and Relating to Self & Others how will the member learn new skills? How will the member learn to respectfully work with others and work in a group setting?
- Turn your record book in the Extension Office by September 1 for review by other Independent Member Leaders.
 - Parent/leaders for Independent member must participate in the review of other non-family independent member record books.
 - If only one Independent family exists, the Exec. Committee of Fergus/Petroleum Leaders' Council will be responsible for reviewing Independent members' record book for 4H year completion.
- The proposed policy change was seconded by Johnnie Schultz. The motion passed unanimously.
- Funding Request for National Congress Participation

Date of Next Meeting: Thursday, February 13, 2024

- Kylie Crawford gave a short presentation on receiving a 4-H State Award, which makes her eligible to attend National 4-H Congress. National 4-H Congress is held in Atlanta the week of Thanksgiving. The anticipated travel costs are \$1,150. Kylie has already received \$300 from her club and has raised \$450 on her own from quilting projects. Chris England will be attending as a chaperone and there are 13 4-Hers representing Montana.
- Hailey Gallagher made a motion to award Kylie Crawford \$400 for her National 4-H Congress travel expenses. The motion was seconded. During discussion, Yvette Hersel amended the original motion to specify that the funding come from the Youth Trips account within the Leader's Council account. The amended motion was seconded Tom Tiarks and was approved unanimously. The final amended motion passed unanimously.
- Yvette Hersel then moved to an additional \$200 to Kylie Crawford for her travel expenses to National Congress, specifically out of the Congress travel fund. The motion was seconded by Judy Martin. After much discussion with positive support, the motion passed unanimously.
- No other new business was brought forward. A thank you was verbalized for Sonya and Chris for their organization of the banquet.

Adjournment was moved by Virgil Tholt and seconded by Davey Storfa. Meeting adjourned at 5:26 pm.

Fergus/Petroleum County 4-H Leaders Council Annual Meeting 2024 Committee Reports

Livestock

This year was a year of change in Livestock Committee. We started the process of onboarding 2 new superintendents with Trevor Gervais as swine superintendent and Amanda Gillett as sheep/goat superintendent. With new personnel comes new ideas, one of these ideas was to revamp the pavilion set up for the 2024 Central Montana Fair. Policy changes that were brought forth and passed in November for next year's fair include: not conducting the Super Animal Awards. All other proposed policy changes were voted down.

Horse

The horse committee passed the policy change that we will adopt the Montana 4-H State Horse Show rules and keep them up to date with the State rules each year. This will allow our kids to practice and follow the same rules as they would at the state level and not require them to learn a different set of rules each year. The second policy change that passed was to get an AQHA carded judge for both Ranch and Performance Horse. The committee is looking forward to clinics in the Spring for both ranch horse and performance horse. Fair this year went well and we are looking forward to the next year.

Static

Early this year volunteers hosted several project workshops, and we are looking forward to providing that opportunity again this year. Fair went well this year with 313 static entries. Another successful indoor auction with Chris Miller as our auctioneer, and an increase in items and buyers. We had 53 register buyers, 27 items sold, and \$137.00 was the average per item sold. As a fundraiser we sold stickers that were designed by members in our 4-H community. We are still selling them at the office.

Food Booth

The Farm to Table hamburger program continues to be a success and the community appreciates having great tasting hamburgers. Thank you to the generous donors — Wichman Herefords, RancHers- Mariah Shammel, Abby Majerus and Jessi Olson, Phillips Moccasin Mountain Beef, and Central Montana Cattle women. Yvette has already secured the donors for our 2025 fair. The Farm Bureau donated water again this year. The two new doors, updated electrical, lighting, and the new cement pad in front made a nice addition this year. We are also looking into replacing 2 of our freezers this year.

We are saddened that Yvette has turned in her resignation as Manager of the food booth, but we are glad she is willing to offer guidance and will be able to spend quality time with her daughter during the fair. Mindy Henderson will continue to manage the food booth but does need a co-manager. If you know of anyone looking for a summer job, please send them to the office.

Small Animal Committee

The Small Animal Committee hosted their annual workbook workshop, extending it to include large animals. The workshop was well attended. The showmanship clinic was held at the small animal barn and ran by members stepping into leadership roles, sharing their knowledge and passion for the project. The committee was pleased with the judges they had for all the species and felt like the kids received good feedback from each of them. The dog project obtained some new equipment thanks to a very generous donor and her company. The best in show received a buckle with their name and their animals' name on it thanks to previous sponsors. The showmanship winners received engraved water bottles and embroidered blankets thanks to our repeat generous sponsor. The agility classes in both rabbit and dog once again received metal plagues donated by the Tholt family. The kids are so grateful for the added prizes. The small animals had a photographer this year and it was well received by families. The committee passed 3 new policies. The first is to add a pen of 2 broilers to the market lot. The second is to break market classes into species specific (turkeys, hens, meat, and ducks) and the third a member may only show their own animal and make ID cards required and due to the office by June 1st, exceptions to be approved by the committee.

Extension Office

We welcomed our new FCS/4-H Agent, Riley Larson, in June. She has been getting her feet under her by taking the lead with the Horse Committee and will be transitioning into Static as the new year begins. We have been working with Judith basin planning the tweeny and senior camps. Enrollment is well underway, and we have many new families joining our awesome 4-H community. Our office is looking forward to an amazing new year.

*Amendment XX ARTICLE XV

Requirements for Independent Members

Members or Cloverbuds enrolling as "Independent" must meet the following requirements annually:

- A parent or guardian must enroll and and pay dues as a 4-H Leader
- Pay yearly membership / Cloverbud dues and family postage fee (if desired communication method)
- Submit a 4-H New Year Report to the Extension Office no later than January 1st (enrollment deadline). The New Year Report must list the Independent Members' goals for completion of the following activities in the 4-H Year:
 - O Community Service Activity how will the member give back to the community?
 - Communication & Public Speaking how will the members use communication skills to engage and/or educate non-family individuals?
 - Engage in Learning and Relating to Self & Others how will the member learn new skills? How will the member learn to respectfully work with others and work in a group setting?
- Pick up items at least monthly from your mailbox in the Extension Office
- Work a shift in the 4-H Food Booth during Fair
- Have current Food Safety Training
- Have TQA if in a Livestock or Small Animal Project
- Turn your record book into the Extension Office by September 1 for review by other Independent Member Leaders.
 - Parent/leaders for Independent member must participate in the review of other nonfamily independent member record books.
 - If only one Independent family exits, the Exec. Committee of Fergus/Petroleum Leaders' Council will be responsible for reviewing Independent members' record book for 4H year completion.
