Discussion: Emeritus Email Policy

Email sent to emeritus in early Jan 2025

- Require “affiliate” status to keep email
- Annual paperwork (two pages) includes
 - Justification
 - Background check (department pays?) OR letter stating background check isn't needed
 - Signature by department chair, dean, provost
- Deadline for paperwork extended until May 2025

Emeritus Email Policy Faculty Concerns

- Small % of accounts at the university (~180)
 - Still higher than expected – need a way to inactivate unused accounts
- Annual paperwork burden for both faculty and departments
 - Justifications, background checks, signatures from department chair/dean/provost...
- Alienating for Emeritus faculty doing (often volunteer) work for the university, colleagues, community
- Nonstandard at R1 universities
- Many have built a large, international community with these emails that will be difficult to replace
- Harder to “stay in the loop”, both at MSU and in broader community, with email changing

Informational Update: University Council

Volunteer Policy, 4.g:

- Current: *Volunteers may not displace or perform work that would otherwise be performed by regular employees.*
- Suggested edit (denied): ~~*Volunteers may not displace or perform work that would otherwise be performed by regular employees.*~~
 - Violates FLSA
 - Some volunteer work provided by retired/emeritus faculty would not be considered “work” and not fall under this policy

*The FLSA recognizes the generosity and public benefits of volunteering and allows individuals to freely volunteer in many circumstances for **charitable and public purposes**. Individuals may volunteer time to religious, charitable, civic, humanitarian, **or similar non-profit organizations** as a public service and not be covered by the FLSA.*

Q&A, Lambent spaces

What is the new Lambent Spaces Technology and how does this work?

The system works by processing wifi connection data from the many access points in the building. That data is already collected by UIT, this program just anonymizes it and then processes it to help us understand how the building is occupied. We work with Lambent to map zones in the building based on where the wifi points are to help granulate the data in a way that can be more useful such as a classroom or group or a group of offices all associated with the same department.

How the data will be used?

Exactly how the Space Management Committee and Space Planning will use the data is TBD. We are excited about the pilot project and seeing what the data output generated looks like but need to see some of that before we can really assess how it can best be utilized. Having real data on how space it used, not just the anecdotal data provided by users will be helpful though.

How granular is this data - what is the size that can be resolved by this technology?

The area zoned is dependent on the number of access points and their location. We can look at areas as small as 1 specific room potentially, if it has a wifi access point in it and there are other access points around it that could help separate connections. We have some small groups of just a couple rooms but generally they are larger groups like an office suite or a lab and associated support and office spaces.

Does this mean that students/faculty/staff need phones or computers connected to wifi while working to count as using the space?

Correct, if an individual is in a space and has no connected device they would not be counted. It's 2025 though so the number of people walking around with no wifi enabled devices is virtually 0 at this point.

Do the devices have to be in use or just connected?

Just connected.

Lambent Spaces Q&A, continued

What is the plan to roll out this software (timeline and next buildings?)

The pilot is for 1 year, we will make decisions based on that, probably after 4-6 months so we have time for procurement and such. The next building will likely be Barnard due to the backfill needing to happen when Gianforte Hall opens.

Would you be comfortable with me sharing this information with faculty senate, and if so is there anything else you would like faculty to know?
